Exceptions: Recipients of housing and child benefits must apply for all benefits separately.

Day trips and class excursions All costs for class excursions and day trips are covered. Spending money is not covered.



Learning support Costs for extra-curricular learning support can be covered. Please note: You must first file a separate application.



School supplies

Pupils receive a lump sum on 01.08. and 01.02. of each year. The amount is increased annually by the same percentage as the standard



Lunch School or kindergarten lunch fees shall be covered.



Transportation

Participation in sports and culture All children and young people under the age of 18 are entitled to 15,00 € per month. This can be used, for example, to pay for a club membership, to take part in recreational activities, or to attend extra-curricular music lessons at a music school.

WHO?

Who is entitled to these benefits?

Beneficiaries are children and families receiving

- > Citizen's Allowance (Bürgergeld), or the social security benefit in accordance with SGB II (Sozialgesetzbuch (German Social Code))
- > Social assistance benefits in accordance with SGB XII (Sozialgesetzbuch (German Social Code))
- > Housing benefit (Wohngeld)
- Child benefit (Kinderzuschlag)
- > Benefits in accordance with the Asylum Seekers' Benefits Act (Asylbewerberleistungsgesetz).

Children and pupils up to the age of 25 are entitled to the education package. Benefits for participation in social and cultural life are granted until the age of 18.

Young people and young adults receiving a training allowance are not entitled to these benefits.
